Wirt Davis moved to approve the Group UIL Catastrophic/Accident Insurance for students. John Lieb seconded the motion, and it carried 5-0.

Jason Varnon made a motion to designate Jeremiah Martinez as the IPM and Asbestos Coordinator. Wirt Davis seconded the motion, and it carried 5-0.

No action was taken on new playground equipment.

Trustees set June 20th, 2023, at 7:00 p.m. as the date and time for the June board meeting.

At 8:59 p.m. on May 25, 2023, the Board of Trustees convened in a closed session in accordance with the Texas Open Meetings Act. The board ended its closed session at 9:12 p.m. on May 25, 2023.

John Lieb made a motion to approve a new Guardian. The motion was seconded by Wirt Davis and carried 5-0.

Superintendent Burrow reported:

The current enrollment is 109 students.

STARR assessments are complete and multiple field trips are in the books. ART classes took a trip to the Citadel in Canadian. High School Art went to the Panhandle-Plains Historical Museum in Canyon. Elementary went to AMP D Adventure Park, and 4th grade attended the Water Festival in Perryton.

Burrow also reported that he had hired a custodian, and cleaning had begun by Friday the 19th. The new suburban has arrived, and we will receive the two new buses this summer. The new weight equipment will be paid for with bond money.

He also gave the Trustees a brief legislative update on school vouchers and tax relief.

The meeting was adjourned at 9:32 p.m.
